Suppliers Manual For the Qualification phase on IT4BUY by Ariba Network





## 1 Qualification Contribution

To ensure the efficiency of the qualification process, Italgas asks the supplier for a contribution to be paid at the time of the application for a new qualification and upon renewal of the same.

Before completing the Qualification Questionnaire, you will receive an **email** with the **instructions for paying** the contribution to be carried out by bank transfer with specification of the reason for payment indicated in the text of the email.

**NOTE:** Failure to pay the contribution by the deadlines set will result in the non-acceptance or non-renewal of the qualification with the consequent exclusion from the Vendor List of the Italgas Group. The amounts paid will not be returned if the qualification is suspended or revoked.





## 2 Completing the Qualification Questionnaire

Clicking on the link in the email inviting you to proceed with qualification, will bring you to the **questionnaire page**. Fill in the required fields on the form. Fields marked **\*** are mandatory.

#### 4. Compose message:

This feature allows you to write and send a messages directly to the Italgas operators, if you need to supplement your answers to the questionnaire or request information.

## Completing the Modular questionnaire

To complete the process, Italgas requires some **documents needed** to assess the Qualification. These documents must be attached on the IT4Buy platform using the so-called **Modular Questionnaire**.

Once you have completed and submitted the Qualification questionnaire, you will receive an **email** requesting the necessary documentation for the Goods Category(s) you wish to qualify for and the relevant deadline for uploading it.
